

Meet Don Burke...

Don Burke is a candidate for ASQ Section 0511 Chair. Don has spent 25 years in the Quality field and has been an ASQ member for 10 years. For the last fifteen years, he has been with the U.S. Postal Service; he works in the Engineering Department as a Quality Program Manager. His current role deals with the deployment of Postal automation equipment.

Don began participation in ASQ during the early days of his career. Like many members, he was attracted to the organization in order to pursue continuing education. He became interested in the certifications offered by ASQ. Don has gained recognition from ASQ as Certified Quality Manager, Certified Quality Engineer, Certified Quality Auditor, and Certified Software Quality Engineer. POWERS AND DUTIES OF SECTION OFFICERS

The Section Chair shall be the chief executive officer of the Section, and shall preside at all meetings of the Section and of the Section Executive Committee. He/she shall appoint all standing and additional committees, and shall be an ex-officio member of all committees of the Section. The Chair shall represent the Section in all matters involving meetings or other contacts with other local, regional or national groups, or shall appoint an alternate. In the absence of the Section Treasurer, the Section Chair shall sign any duly authorized checks or other drafts upon the funds of the Section.


The Section Vice Chair/Chair-elect shall develop short-range plans for the year and develop the organization to implement the plan. In the absence of the Section Chair, the Section Vice Chair /Chair-elect shall perform all the duties and shall be vested with all of the powers of the Section Chair.

The Section Secretary may receive applications and initial dues from applicants for admission to membership in the Society, and applications for advancement to the grade of Member or Senior Member of the Society. The Section Secretary shall maintain a complete and accurate roster of the names, addresses, and grades of membership of all members of the Society affiliated with this Section and of all enrolled Students in this Section. This responsibility may be delegated to the Electronic Media Committee Chair, as appropriate. The Section Secretary shall keep a complete, accurate, and up-to-date record of all Executive Committee meetings and the location of official Section documents, Section owned equipment, and Section owned educational resource materials. The Section Secretary shall prepare and submit portions of the Annual Report specified in the Bylaws. The Section Secretary shall serve as official correspondent between the Section and the Executive Secretary of the Society.

<u>The Section Treasurer</u> shall maintain records of all remittances for Section operating expenses under the provisions of the Bylaws. He/she shall have custody of all other monies and securities belonging to the Section. He/she shall deposit all such monies to the credit of the Section in such depositories as may be approved

by the Section Executive Committee, and shall disburse the same as authorized by said Committee. The Section Treasurer shall sign all duly authorized checks or other drafts upon Section funds, in accordance with the provisions of the Bylaws. The Section Treasurer shall be bonded in an amount fixed by the Society Constitution. The Section Treasurer shall keep accurate and

complete records of all receipts and disbursements of the Section. He/she shall make all his/her books and all supporting papers available, upon request of duly sanctioned authorities. The Section Treasurer shall prepare and submit those portions of the Annual Report specified in the Bylaws.

Presentation: "QuEST and TL9000" Speaker: Gary Reams

Gary Reams is Director, Quality Programs Department, for NEC America, Inc.'s Public Networks Group. He has been with NEC since 1983 and was project manager for their successful ISO 9001 certification. He also represented NEC as a team member on NEC's successful and early effort to obtain CSQP recognition. NEC was one of four companies to pilot Bellcore's CSQP program.

In 1999, NEC will pilot the newly developed TL9000 standards as developed by the QuEST Forum. G. Reams has recently joined the QuEST Forum's Overview Working Group and will have responsibility disseminating TL9000 information throughout the NEC organization.

Gary Reams will provide an overview of Quality Excellence for Suppliers of Telecommunications and TL9000. The overview will include a brief history of the QuEST Forum, participants, organizational structure and unique qualities as compared to ISO 9000 and QS9000. The QuEST Forum and TL9000 should be of great interest to all involved in the telecommunications industry since major service providers and suppliers are driving it. Report from the MOP Study Group

March 16, 1999: Fifth Anniversary Party

This meeting was devoted to the single task of celebrating the fact that the MOP Study Group was five years old this month. At our meeting, amidst the balloons on the ceiling and the confetti on the floor, we consumed pizzas and birthday cake, sang happy birthday to ourselves, and approved the new MOP Group fight song composed especially for the occasion by MOP Poet in Residence, Gerard Fehy. With apologies to Notre Dame, here is the MOP Fight Song:

Cheer, cheer, the MOP Group is five. We have endured, we are alive. Sink and Tuttle were our guide And with Carl Thor, we did thrive. Quentin Conroy, he is the best. He has provided space without rest. MOP Group members never fail Though some are often off the scale.

Cheer, cheer our MOP Group's the best. We measure up, we pass the test. Raise your Balanced Scorecards high And Activity-Based Cost 'till you die. We never falter, we never rest. We measure outcomes with elan and zest. While our loyal leader, Bob, Keeps doing a damn fine job.

We presented Jim Knowlton, the President of the VSE Corporation (recently registered to ISO 9001), with a plaque suitably inscribed with our appreciation for being a gracious host these five years.

We recognized 12 "Frequent MOPers" in two categories: Five Year Frequent MOPers who attended more than half of the 56 meetings and One Year Frequent MOPers who attended more than half of the last 12 meetings). Next, we recognized the 10 "MOP Producers" who either presented a topic or found a speaker for a meeting. Data on meeting topics and speakers shows that 59% of all meetings have been manageg by MOP members themselves which means we really are a study group!

After the Recognition Time, we walked down memory lane by reviewing the list of the great variety of topics that we have studied in the last five years. Individuals shared what they learned and how they benefited from MOP Group participation.

April 21, 1999: Cost of Quality

Roger Mercier, Director of Product Assurance for Quest Communications (the fourth largest long distance telephone company in the nation), gave a very

insightful talk on the components of the costs of quality and added his personal observations on why few companies implement a cost of quality approach. Roger said that the cost of quality should really be called the "cost of poor quality" because it addresses the question of the amount of dollars at stake when things are not done right the first time. Roger also said that quality is not free and that, in fact, it is costly; however, a successful cost of quality system will pay for itself.

Most of the costs of poor quality are hidden, meaning they are not measured and they are not visible in budget allocations. Scrap, rework, and warranty costs are the components of poor quality that are typically visible. Often hidden from view are such things as down time, excessive inventory, decreased capacity, delivery problems, lost orders, and management time taken to correct problems.

Roger's presentation walked the MOP Group through a comprehensive cost of quality model that contained all cost of quality components. His model shows total process cost to be composed of Cost of Quality and Cost of Production. Cost of Quality is composed of Cost of Conformance and Cost of Nonconformance. Cost of Conformance is composed of Prevention and Appraisal. Cost of Nonconformance is composed of the visible and hidden costs of failure and poor quality.

Roger suggested that barriers to implementing a Cost of Quality system include: (1) accounting systems that cannot provide the needed cost data, (2) "buried costs" that are not reported, and (3) traditional attitudes that say, ""That's just the way we do things here."

Telecommunications Industry Develops ISO 9000-based Requirements and Metrics

MILWAUKEE – The telecommunications industry has launched a worldwide initiative to develop TL 9000, a standardized set of quality requirements incorporating ISO 9001 language. As many as 10,000 companies will find this requirement applicable to their business.

The Quality Excellence for Suppliers of Telecommunications Leadership Forum (QuEST), developer of TL 9000, is a partnership of telecommunications suppliers and service providers. QuEST Forum is striving for measurable, industry-wide, quality improvement through the implementation of quality system requirements and leading-edge metrics. The global nature of the telecommunications industry is a key driver behind the development of TL 9000. It is estimated that improved quality in this sector could result in savings as great as \$10-15 billion per year.

The American Society for Quality (ASQ) has been chosen as administrator for the QuEST Forum. "This is an exciting challenge for ASQ that is well aligned with ASQ's strategic plan. Our goals are to perform as a strategic partner, implement the Forum's vision, and establish business processes," Brian LeHouillier, ASQ's director of programs and operations said.

The inclusion of metrics is the most significant added feature of TL 9000. The Forum expects they will provide a new driver for process improvement, and are vital for success. "The metrics to be included in TL 9000 are intended to link quality improvement to business issues and help senior corporate executives appreciate the value of quality management systems. ASQ wanted to be part of that initiative," said LeHouillier.

Registered Companies Asked to Comment on Proposed Changes to ISO 9000 Standards


MILWAUKEE – The 25-30,000 US companies registered to the ISO 9000 quality management system standards have the opportunity to comment on the significant changes and revisions being planned for release late next year, according to the American Society for Quality (ASQ).

ASQ is accredited by the American National Standards Institute (ANSI) to develop generic quality and environmental management systems, quality assurance and control, dependability and applied statistical methods standards.

The review process, repeated every five years, has resulted in substantive changes, according ASQ. Companies are urged to provide comment before July 31, 1999 by securing a draft copy of ASQ paper T1400, the recommended new standards. Instructions for comments are contained within the summary. Cost of the document is \$30 and can be obtained through ASQ at 800-248-1946.

Companies currently registered to the standards are asked to review the new guidelines against their current systems. These companies can then work with their system registrars on a transition plan.

The next issue of **QualityMatters** will be July 1999.
